The regular meeting of the Town Board was held on August 8, 2023 at the Hermon Town Hall.

The meeting was called to order at 6:00 p.m. Pledge of Allegiance said by all. Minutes of the previous meeting as submitted were approved on motion by Bernard Reed Jr. Seconded by John Reed. All in favor and carried.

SLC Legislator Larry Denesha

- Additional 10 miles of paving approved(\$1,200,000.00)-(SLC has 573 miles of road to maintain and generally paves 28 to 32 miles annually)
- Established a "Capital Reserve Fund for the purpose of Capital Project Management of Equipment to whenever possible, avoid financing of equipment and begin planning for the future.
- 9 years ago, we were borrowing \$11-12 million dollars each year, with interest payments of \$700-800k.
- 9 years ago, we passed a resolution committing to a 15% unappropriated fund balance...and We achieved it!!
- Solid Waste Fees(effective October 1, 2023
 - DANC has imposed a \$3.00/ton increase in tipping fees.
 - Recycling tipping fees have increased from \$13.27/ton in 2022 to \$104.82/ton in 2023
 - Recycling fees for tires have increased from \$16800/ton to \$193.20/ton
 - Solid Waste is an Enterprise Fund that relies solely on fees charged to haulers and the public to finance its operations.

A Resolution "Authorizing the Solicitation of Bids for Renovations at the Public Safety Complex" In 1994, the existing building was converted from a Cold War era emergency bunker to a Public Safety Complex housing the Sherriff's Office, Emergency Services, Planning, Conflict Defender and NYS Police. There will be a new state-of-the art Public Safety Answering Point(PSAP) or commonly referred to as the 911 Center, upgrades to the radio system, an additional 2 dispatcher stations and capacity for 2 more.

Historian Report Lenore Zaunere

On Saturday afternoon, July 15th, 2023 at 3:30, the Trout Lake Hamlet Historic Marker was officially installed. Visitors gathered at the Marker which is installed, roadside, on County Rt. 19. Again, we thank Laura and John for giving permission to the Town of Hermon for placing it there in close proximity to the calculated location of Asa Gardner's popular and well documented Trout Lake Hotel.

The dedication ceremony was enthusiastically attended, and Lenore Zaunere, Hermon Historian, presented a short history of the Hotel, its founder, Asa Gardner, and its seminal importance to the growth and development of the Trout Lake community. Special mention was given to the Highway Superintendent, Brian Brunet and his crew for their installation of the marker in the Fall of 2022, to David Lowry, a Trout Lake resident who provided interesting maps and photos relevant to the research of the project, to Jeannie Hamilton for her support and encouragement, and to Roger Zaunere, for his digitization and technical support. A remembrance comment was made about Mike Perry, who enthusiastically supported the historian's efforts to apply for the Pomeroy Grant that paid for the marker.

Lenore has been in contact with the Native American Archeology Department of the NYS Museum in Albany. She is researching a story about certain artifacts that were found in Hermon and noted in a letter written by a former historian which has been recently located in the archives of the Hermon History Center. This research and other contacts in progress may be pertinent and provide valuable information for another historical marker called "Legend & Lore" Marker.

There is a need for more file cabinets at the History Center. Lenore is working on a massive project in order to organize by subject matter, alphabetize and be able to locate relevant pieces of historical data from the voluminous materials at the History Center. Please be on the lookout for file cabinets that are being offered by office managers who may be clearing them out.
